1. Upon official admission to the show, you will be invoiced for the allocated units. This balance is payable within 30 days from the date of the invoice. Any delay will result in a 5% surcharge. **CANCELLATION OR SPACE REDUCTION:**

The exhibitor may cancel only by giving written notice to MDNA and complying with the terms hereof. In the event an exhibitor cancels all or part of the exhibit space applied for following the submission of the Stand Application and Contract Form, Exhibitor agrees to pay as liquidated damages the following:

Cancellation on or before November 1, 2017 – 25% of total participation cost;

 Cancellation after December 27, 2017 – 100% of total participation cost
